Hawaii	S.B. 823	Requires insurers to pay the additional cost of OEM parts when recommended by vehicle manufacturer	Carried over to 2020 session
Illinois	S.B. 1760	Creates the New Vehicle Buyer Protection Act of 2019 - states that any manufacturer who is unable to repair or service a vehicle within a reasonable amount of times they must replace the vehicle	Carried over to 2020 session
Illinois	S.B. 2104	Prohibits the use of aftermarket or remanufactured parts for vehicle repair unless authorized by the customer in writing	Hearing held 5/8 – no vote was held
Massachusetts	HB 362	Whenever repairs are necessary to the visible exterior sheet metal or plastic parts of a damaged motor vehicle, any insurer or repairer preparing a written estimate of the cost of such repairs shall clearly identify in such estimate each major generic crash part to be used which is not manufactured or supplied by the original manufacturer of the motor vehicle. Montana	H.B. 252	Requires written consent for aftermarket parts	Failed upon adjournment
Nevada	A.B. 173	Prohibits an insurer from requiring the use of aftermarket parts when repairing a vehicle	Failed upon adjournment and will not carry over to next year
New Hampshire	H.B. 664	Require insurer to reimburse a repairer which follows OEM recommended repair procedures	Veto sustained
New Jersey	A.B. 5225	Requires written statement summarizing vehicle warranty coverage for aftermarket and recycled parts - Magnuson – Moss disclosure bill	Awaits consideration before the Assembly Consumer Affairs Committee
New Jersey	S.B. 1712	Requires motor vehicle dealers to provide purchaser a written statement on aftermarket and recycled parts warranty coverage	Passed Senate

Oklahoma	H.B. 1884	Tax credits for employees of vehicle manufacturing companies	Approved by Governor Kevin Stitt (R) - effective Nov. 1
Oregon	H.B. 2885	Relates to remedies for manufacturer failures to conform motor vehicles to terms of express warranties	Failed upon adjournment and not eligible for consideration in 2019 Legislative Session
Rhode Island	H.B. 6104	Owner of vehicle must be notified in writing if aftermarket glass installation requires re-calibration	Failed upon adjournment and will not carry over to next year
Rhode Island	SB 850	This act would require that the owner of a vehicle be notified in writing <u>or by electronic mail</u> that installation of aftermarket glass may require re-calibration of safety related systems, <u>or the vehicle may not function as designed.</u>	Referred to House Corporations Committee, awaits further consideration
Texas	H.B. 1348	Discourages the use of aftermarket and remanufactured parts when paid for by insurers.	Awaits further consideration in House
West Virginia	S.B. 49	Requires new OEM parts on any vehicle during the 1 st year of its manufacture and for two years following	Failed upon adjournment
Wyoming	S.B. 95	Requires consumers to pay for the difference in cost if selecting OEM parts over aftermarket parts.	Failed upon adjournment

Hawaii	HB 145	Decreased the required frequency for vehicle inspections	Carried over to 2020 session
Hawaii	HB 240	Repeals requirement that passenger cars obtain a certificate of inspection	Carried over to 2020 session
Hawaii	SB 446	Vehicles ten years of age or younger will only be require to a two-year inspection	Carried over to 2020 session

Pennsylvania	SB 743	This measure would eliminate the annual vehicle emissions testing and replace it with a 2-year testing requirement for gas-powered passenger cars, vans, and light-duty trucks older than 8 years after manufacture in counties that require emissions testing. Texas	H.B. 2696	Would eliminate regular mandatory vehicle safety inspections for noncommercial vehicles	Failed upon Adjournment
Vermont	HB 217	This bill proposes to eliminate the annual vehicle safety inspection for all vehicles except school buses.	Carried over to 2020 session
Vermont	SB 84	This measure proposes to limit the number of model years for which emissions inspections are required.	Carried over to 2020 session

California	AB 1411	This measure creates goals related to the procurement of zero-emission medium and heavy duty vehicles and corresponding infrastructure.	Hearing postponed - Assembly Committee on Transportation
California	SB 44	Requires the State Air Resource Board to develop a strategy for the deployment of medium and heavy duty vehicles that meet greenhouse gas emissions standards.	Sent to Governor Gavin Newsom (D)
California	SB 216	The bill would require, on or before December 31, 2020 the state board to hold a public workshop on the heavy-duty truck exchange and to help air pollution control and air quality management districts add a heavy-duty truck exchange as an eligible project under the program. Massachusetts	HD 4366	This measure would increase operational safety for keyless ignition technology in motor vehicles	House docket filed
Michigan	HB 4846	This measure states that the department will not issue a permit under this part that authorizes new or increased emissions in an area of high population density unless the permit requires the planting of trees or other vegetation.	Introduced; Referred to the House Committee on Natural Resources and Outdoor Recreation
Michigan	SB 530	This measure states that it amends and changes the definition of the different category facilities are.	Passed Committee
New Hampshire	LSR 2361	This measure requires the adoption of vehicle emissions standards based on the California Clean Car Standards. Bill text not yet available.	Prefiled
New York	AB 7534	This measure increases the certificates of registration for entities that manufacture or assemble zero emissions vehicles while offering repair services to those vehicles throughout the state.	Referred to Assembly Transportation Committee

Massachusetts	HB 3143	This measure establishes requirements for autonomous vehicles to be operated on public roads. This measure also removes original manufacturer's liability from incidents involving vehicle converted into autonomous vehicles.	Referred to Joint Committee on Transportation
